- (c) to oppose the granting of planning application 2012/0706 change of use of ten parking spaces to hand car wash and valeting operation and erection of canopy and installation of office at Tesco Stores Ltd, Blue Boar Lane on the grounds that it reduces the number of existing parking spaces available to customers in an already busy car park, is too close to roadways and walkways which could potentially be covered in water runoff, would be an eyesore to those living opposite and detrimental to the amenities of future residents of dwellings already planned to be built close to the boundary with Tesco Ltd car park.
